# **Update on The Downs - Exemption Request & Downtown**

The Downs came forward to the Council with a proposal of building 289 units requiring exemptions over the next 3 years. Jon Crasnick provided written comments to the council in support of the proposal, based on a unanimous electronic vote of the SEDCO Board (October 5-6,2022). The Council approved the proposed exemption, but they placed a 6-month hold on all additional exemptions. The Council requested that Councilors McGee and Anderson come back to the Council by April 2023 with proposed changes to the ordinance.

# **GMO Revision Questionnaire/Survey**

(Committee Chairs, Council Members, Department Heads)

In October 2022, the Town Council placed a six-month hold on "exemptions" in the current ordinance that regulates the pace of residential growth in Scarborough. The ordinance, known as the Growth Management Ordinance, contains a section that addresses exemptions to the permit process for specific purposes and/or specific projects.

The Town Council assigned Councilors Jon Anderson and Nick McGee the task of reviewing and updating the ordinance to address concerns about the GMO process and to ensure consistency with the 2021 Comprehensive Plan.

Regulating the pace of growth is one part of a wholistic approach to managing growth. Other tools include our development ordinances such as zoning, subdivision, site plan and impact fees.

As part of our deliberation and outreach process, we are asking key leaders in the community for feedback on a range of development issues, and how the pace of residential growth impacts the work they do in the community. We appreciate you taking the time to carefully think about this issue and complete this questionnaire.

Please provide responses by December 23, 2022.

# **GMO Summary**

The existing GMO allows an **annual allocation** (fixed number) of residential permits per calendar year. This number is revised every two years.

- 1. 144 total permits each year (each permit equals one residential unit)
- 2. No more than 30 permits in the Rural Districts (West of the turnpike)
- 3. No more than 20% (29) of total permits in a common scheme, except no more than 30% (43) of the total in the Crossroad Planned Districts (The Downs)

The existing GMO also allows for **exemptions** including:

- All Repair and Replacement Units and Gift Lots
- All Affordable Housing Units
- All Manufactured Housing Units in a Licensed Community
- Up to (100) One-Bedroom Multi-Family Units (until 12/31/2024)
- Up to 10 Workforce Housing Units Per Year
- Up to (289) Mixed Use or MF in Crossroads Planned Development (until 12/31/2025)

In addition to standard exemptions, the existing GMO allows for an **exemption process** to be heard through the Town Council if the unit is within the designated growth areas, the unit is part of mixed-use or multi-family, and provides public benefit.

Continuing to review and update the Town's Economic Development Vision, produced jointly by the Scarborough Community Chamber of Commerce and SEDCO, to identify more specific tools and strategies to effectively cultivate entrepreneurship, business retention and attraction.

## III Continue Developing an Intelligence System for Decision Makers.

Offer a business resource center, which can connect all levels of businesses to any available local, regional, state or federal sources of assistance. SEDCO should continue to develop data needed by both elected officials and businesses to support economic development decision making.

- A. Develop a Digital Resource Hub
- B. Monitor Access to Capital
- C. Create a supportive culture for entrepreneur's and independent contractors including potential co-working spaces
- D. Assess Competitiveness (Taxes, Fees, Land Availability, Housing Availability)
- E. Develop Key Performance Indications for Business Retention and Entrepreneurship
- F. Develop baseline growth report in partnership with Town

## IV Continue Strong Business Communication.

Track and identify issues and opportunities in the business community through a strong communication program. Through SEDCO, the Town will continue to work with the Scarborough Community Chamber of Commerce and Scarborough Buy Local to support effective communication with the business community.

- A. Work with schools to explore ways for businesses to be involved in education
- B. Support community festivals and events that bring the community together
- C. Develop B-to-B and B-to-C lines of communication
- D. Define the role of business in achieving community goals and in increasing livability
